

Review Meeting Chaired by District Collector on June 25, 2024, in Narnoor HQ, Narnoor Block

On June 25, 2024, a comprehensive review meeting was held at Narnoor Headquarters, Narnoor Block, under the leadership of the District Collector. This crucial meeting brought together key stakeholders, including PO ITDA, District Officers, DM&HO, PD DRDA, DAO, DWO, ACDPO, District Manager CSC, E-District Manager, and all block officers. Additionally, Anganwadi Teachers, ASHAs, ANMs, Farmers, Panchayat Secretaries, SHG women, Community Coordinators (CC), Village Organizations (VO), and NGOs were part of this significant gathering.



Agenda and Key Discussions

The District Collector meticulously reviewed each department's performance, analyzing current data and the overall situation of the block. The primary focus was to assess progress, identify challenges, and strategize for the future. Emphasis was placed on six critical indicators that need to achieve saturation in the next three months.

Departments Reviewed

1. Medical & Health

- **Focus Areas:**

- Achieving 100% antenatal care (ANC) registration within the first trimester.
- Conducting 100% screenings for diabetes and hypertension for individuals aged 30 and above.

- **Discussion:**

- Current status of ANC registration and the importance of early detection and regular monitoring for diabetes and hypertension were discussed.
- The Collector urged health officials to intensify efforts in these areas, ensuring comprehensive coverage and follow-up.

2. Women and Child Welfare

- **Focus Areas:**

- Providing 100% supplementary nutrition to pregnant women.
- Improving the infrastructure of Anganwadi Centers, including sanitation and drinking water facilities.

- **Discussion:**

- The Collector reviewed the nutrition programs and emphasized the need for robust monitoring and timely distribution of nutritional supplements.
- Action plans were formulated to address gaps and ensure all pregnant women receive the required nutrition.

3. Agriculture

- **Focus Areas:**

- Achieving 100% target for soil health cards.

- **Discussion:**

- The importance of soil health and its impact on agricultural productivity was highlighted.
- Strategies for increasing soil health card distribution and awareness among farmers were discussed, with the aim of improving crop yields and soil management practices.

4. SERP (IKP)

- **Focus Areas:**

- Achieving 100% target for bank linkage funds for SHGs.

- **Discussion:**

- The Collector reviewed the financial inclusion and empowerment of SHGs, stressing the need for timely bank linkages and access to revolving funds.
- A detailed action plan was developed to ensure all SHGs receive the necessary financial support, fostering economic independence and community development.

5. Education

- **Focus Areas:**

- Improving the quality of education and infrastructure in schools under Aama Adarsha Patashala.
 - Enhancing the enrollment and retention rates of students under Bati bata program.
 - **Discussion:**
 - The Collector discussed current educational challenges and proposed solutions to improve school facilities and student outcomes.
- 6. Engineering**
- **Focus Areas:**
 - Enhancing infrastructure development, including under Aama Adarsha Patashala works, Anganwadi center works
 - **Discussion:**
 - The progress of ongoing infrastructure projects was reviewed, and new projects were proposed to address gaps in development.
- 7. RWS Mission Bhagiratha**
- **Focus Areas:**
 - Ensuring 100% coverage of safe drinking water in all households, Schools, Hospitals.
 - **Discussion:**
 - The Collector reviewed the current status of water supply projects and set targets for achieving complete coverage.

Action Plans and Targets

The District Collector provided a clear and actionable plan for the next three months, focusing on:

- **Health Sector:** Enhancing the registration process for ANC, and scaling up screening efforts for diabetes and hypertension.
- **Nutrition Sector:** Ensuring the uninterrupted supply and distribution of supplementary nutrition to all eligible women.
- **Agriculture Sector:** Accelerating the distribution of soil health cards and conducting awareness programs for farmers.
- **SHGs:** Streamlining the bank linkage process and providing necessary support to SHGs for achieving financial targets.
- **Education Sector:** Improving school infrastructure and educational outcomes.
- **Infrastructure Development:** Advancing ongoing projects and initiating new ones to fill development gaps.

Submission of Meeting Notes

A detailed 100-page meeting report, covering the current situation of each department, was submitted to the District Collector. This comprehensive document provides insights into the challenges and opportunities within the block, ensuring informed decision-making and strategic planning.
